Call to Order

Approval of Minutes and Agenda

- May 2020 minutes were approved via email in May.
- September Agenda approved
 - Vote majority/unanimous approval via Zoom (all present (11) approve)

• Who we are and why are we interested in governance

Governance Reflections

- We are working on gaining and maintaining student participation on the Council
 - o Elected students may have had changes to their life situations
 - We need a stronger outreach

Constituent Concerns

- Students receive different, sometimes conflicting advice
 - o Students receive different guidance from different sources
 - Starfish, Banner
 - Perhaps need a consistent system to be used by both counseling and academic advising
 - o Students can go "shopping" for advice
 - Consistent terms occasionally lacking
 - What does "advising" mean?
 - Terms are not uniformly used throughout the institution
 - Faculty access to Starfish
 - There are barriers to faculty participation

- Three different ways of getting to academic advisor program information
- o On-boarding challenges
 - Students need to be directed to one intake location/system
 - Video as direction for incoming students
- o There are number of processes involved in orientation
 - Remote placement testing
 - Information on website
 - O Students don't always do things in a linear fashion
 - May not be a perfect system
- o Could students work hand-in-hand with a counseling team throughout
 - An ongoing relationship between students, counselor, and academic advising for each student for the duration of their degree program
- o Advising Day Oct 20
 - It's difficult to get students the correct information about all resources
 - Do we have enough information about what other faculty groups are doing
 - Can we have some communication college-wide about what's available
- o Program advisors perhaps available over the summer
 - An all-hands on deck approach may be helpful
 - ESH is the questions for program advisors over the summer
- o Can there be one platform/system for student counseling & academic advising
- We need to work on our process first
 - Divest our process from the technology
 - Form follows function
 - Fix the process and the tech will follow
- Our directive for ASC does not directly involve counseling and advising
 - o It's an underlying current, so it's within our purview
 - We could work with Student Services Council on this

New Business

- Additional Goal Discussion:
 - Onboarding process is complex
 - o Students can't register and enroll for classes
 - Currently going through a revamping
 - Does the ASC need to get involved
 - Encourage other departments to use the Chat Bot to serve students
 - o Counseling uses it
 - Were inundated with questions
 - Useful for questions with quick answers
 - Help students plan ahead
 - o Would like more information about systems and services we do have in place already
 - o Is the Starfish contract up soon?
 - We might be a good committee to make recommendations

Guest Speaker (moved in the Agenda to suit our guest's availability)

Samantha Veneruso, Professor of English; Chair, General Studies Program Topic: Lending laptops through General Studies

- General sketch of laptop distribution program
 - o History:
 - Purpose: increase access to OER materials
 - Credit students only (pivoted this semester to fill a need)
 - There was a grant for Z Courses (grant wrapped up in 2019)
 - To help reduce costs for students
 - Accessibility was an issue
 - Distributing laptops to students eligible for OER or online (goal was to increase access to those sorts of classes
 - IT participated
 - o 200 laptops
 - ¼ to ATPA one-on-one coaching
 - ¾ to General Studies
 - Distributed through General Studies and ATPA
 - o 125 laptops still out from last spring
 - Until a safe return plan is in place
 - 150 new laptops for distribution at the end of August
 - Distribution plan was swiftly created and approved
 - Open to any students because of SRT
 - o 10-15 laptops are still available
 - Most common reasons for needing a laptop:
 - Only one device in the house
 - Students have old tech at home

- Students have been using mobile devices
- Laptops lent for whole semester
- May not be able offer this program for winter or spring
- Return process complicated
- o If IT has the capacity to offer more laptops, they will
- o Haven't gone over our limits re: what's available
 - Other moving pieces
 - Less need that anticipated
 - Through the MC Foundation there has been other assistance
 - Grant to support specifically ACES students
 - Students keep the tech
 - Not able to continue distribution any longer this semester
 - Capacity and infrastructure not in place to sustain this program
 - o Created for the emergency situation
 - Students would need to contact General Studies or Foundation if in need of a laptop
 - Laptops will have to come back in
 - This process was managed through the Bookstore before
 - There will be a survey of students later on in the semester
- IT would like more consistency in lending practice between ATPA and General Studies
- o Library used to lend laptops also, but likely not now
 - Library laptops were not lent for the entire semester
- o If a student is in need, there is a process for students to get assistance

New Business Resumed:

- Policy and Procedure updates
 - o There was a email:
 - Three Policy and Procedure Modifications now open for public comment:
- 32500-Flexible Work Arrangements these modifications update the scope and types of "remote work" as well as provide additional clarification around the purchase of College equipment during mandatory remote work status.
- 2. <u>38001CP-Recognition Awards</u> these modifications streamline the retirement resolution process from individual resolutions to a single, bulk resolution. Those also receiving medallions or other awards will still receive an individual resolution.
- 3. <u>43002CP-Board of Trustees Student Grants and Scholarships</u> these modifications update the eligibility requirements for Board grants and scholarships.
