- Early College, Dual Enrollment & MC2 Presentation
  - o Amy Crowley & Akima Rogers
    - Amy leads Early College Program
      - MCPS students to finish high school graduation requirements on an MC campus and begin college career simultaneously
        - o 11<sup>th</sup> & 12<sup>th</sup> grade
        - o organized in cohorts
      - Degrees transfer to MD 4-year institution
        - o For jobs available in this area

- Requirements:
  - o English and Math state assessments in 10<sup>th</sup> grade
  - o MCPS GPA 2.75 or higher
  - Summer transition program
  - Academic Advising:
    - Early College Coordinator
      - To help and connect students
      - Advising
      - Seminars
      - Transition to MC and transition beyond
- Adding many new programs next year
- Spring 2020
  - o 137 Students
  - o 600+ courses
  - o 92% ABC rate (collegewide 80.3%)
  - o 264% Enrollment increase
  - o 137% student increase over the last year
  - o Projections: 500 students 2041 courses
    - MCPS pays
- Transition to remote delivery
  - o Delivery for Summer Transition
  - o Hiring adjunct faculty because of hiring freeze
- Instructional materials a struggle to stay ahead of
  - Biggest challenges going remote
- Total graduates by AY 22-23 : 532
- Savings for students: approx. \$12,700
- Honors sections available
- Broad number of schools nationwide students are applying to

## Akima leads Dual Enrollment

- Ability for students to be high school and college student simultaneously
- Two categories
  - o Umbrella program for individual college courses
  - Middle College Program & Pathways
- 1,200 students are dually enrolled
  - o on MC campus or at high school sites
  - Most from MCPS but other students also
    - home school
    - other MD public schools
- Students typically take courses that a student would take in their first & second year of college
- Increase Fall 2015 473 students 563 courses
- 959 students 1835 courses now
- 83.9% ABC rate spring 2020

- Transitioning online was a struggle (it's usually closer 90%)
- o Enrollment up vs 2019 almost 30%
- Middle College: students are enrolled in college but getting HS diploma through HS and college courses
  - Held only at certain schools
    - Northwest, Northwood, Clarksburg
  - Students may complete an associates while completing HS
- P-Tech is a grate program that includes a career track
- Competing bureaucracies (MC & MCPS)
  - o Growth in Middle College enrollments Fall 2020 378% enrollment increase
  - o Projected total graduates by 22-23: 213
  - Students graduate with an associates and transfer or go into work force
- Questions
  - Cap for winter courses for HS students: 2
    - hard cap
  - o How can we tell if a student is dual enrolled or EC
    - Instructors have no indication
  - Students don't always know if they are in the program
    - Some students are notified until after class started
    - Some confusion for students enrolled in courses
      - at the HS guidance level
      - here needs to be a tighter process
        - Will be addressed with MCPS by coordinators
      - Faculty obligation: just to teach the students that show up
        - o Coordinators will manage concerns
        - Please reach out if a student is absent for a week
      - Accommodations (IEP) at MCPS but must also apply through MC
        - College standards followed
        - Weekly and bi-weekly meetings & information sessions held so students & parents know what to do
- o Conclusion: Faculty should manage students the same as college students and reach out to coordinators with issues
- Constituents: student guest
  - o Geovanka Levine
    - student's microphone was not working.
  - Conclusion: Erika will connect with student and send concerns over email to the Council
