Compliance Update – Julie Martorana and Maria Adams Davidson

- New name: Compliance, Risk, and Ethics Office
- Discussed their Office's areas of responsibilities, the Ethics Program history, their website which includes the Employee Code of Conduct, and EthicsPoint, new confidential reporting tool.
- Doing an awareness campaign in Fall 2017, and in-person training for supervisors in Spring 2018
- Faculty asked for the student complaint link for their syllabi.

Ombuds Office Update - Julie Weber

- Reviewed the one-page summary of FY17 Ombuds Report (full report on website)
 - o 4% of MC employee population visited Ombuds office (within national range)
 - Evaluative Relationships top concern
 - o Organizational, Strategic, and Mission Related second top concern
 - o Values, Ethics, and Standards new category for MC
 - Career Progression and Development
- President accepted the Ombuds recommendations
- Concerns raised by council: understanding the context of the data; manage expectations of employees and advancement opportunities

Communications Committee Update - Cathy Giovannetti

- Progress to date: videos (staff council), college council picture
- Resources: InsideMC, MC Logon Page, MC events calendar, digital signage, Director of Governance written ideas from last year; Bit.ly to track analytics
- Discussion Points
 - Recommended Standards for Council Communication
 - Inside MC meeting dates one week prior to meeting
 - Inside MC and website Group photo with names (September)
 - Inside MC article / video each year
 - Social Media options
 - Newsletters or Bulletins
