Constituent Concerns/Comments

There was a concern about why Montgomery College does not close for Veteran's day, and this constituent believes that Montgomery College should celebrate Veteran's Day on behalf of staff and students who are veterans.

Ethics and Compliance Updates -Vickie Duggan, and Maria Davidson

The Ethics and Compliance presentation highlighted the following:

- Organizational Culture, the meaning of ethics, and behaving ethically.
- Introducing new employees to norms of cultural behavior.

- How high ethical behavior correlates to high productivity and vice versa.
- Communication tones, and protection against retaliation.

IT Updates -Jane Ellen Miller

The IT presentation highlighted the following:

- Focusing on bringing the IT, and the HR teams together.
- Open enrollment now easier to do in workday.
- Multi –factor authentication (2FA)
- Finance training for the Finance department starting early spring 2019.
- Informational and technical alignment planning (ITAP) and a host of other technological improvements.

Presentation on the space in Germantown provided for the Part Time Faculty Resource center provided information on the three dimensional concepts supported in developing this support space:

- Normal dimension: empowering (IPTFES) and envisioning itself as an organization for the 21st Century.
- Formal dimension: to coordinate in an academic atmosphere with other Montgomery College units to expand support and engagement of part time faculty.
- Psychological dimension: understanding the complexity, and looking into the perception of part time faculty.

 - Possibly looking into a budget for emergency supply funds in regards to feminine hygiene products

- o P&P update for including the Peggy BeeBee distinguished staff award to officialize it, in Dr. Long's department. More information coming.
- o Human Resources is working on noncredit students being able to be hired for student assistance jobs along with credit students. Waiting on protocol.
- Waiving fees for noncredit enrollees/students to move to credit courses are in the works.
- o Telework to go through SALT next month and finalized by Nov. and update processes by spring 2019 (Training will be given)
