Vicki Duggan, Chief Compliance, Risk, and Ethics Officer, and Maria Adams Davidson, Compliance, Risk, and Ethnics Office

- Developed a program that will serve some positive outcomes for the College

College Council February 11, 2020 Information presentation on MC website homepage refresh

My name is Sean Enright, and I'm the Montgomery College Strategic Website Manager. Thank you for allowing Marketing and Communications the chance to speak to you today. We want to inform the College Council of our current effort on a "homepage refresh" for the http://www.montgomerycollege.edu/index.html site. (This is just for the homepage itself, "index.html".) Ray Gilmer had suggested that the College Council would be an important conduit for communicating this information.

We are planning a "refresh" and not a "redesign" of the homepage index page. A best practice for website redesign is to revisit the original design every four to five years, and as this homepage launched almost four years ago, we are at an appropriate juncture. With the old Ektron content management system now officially retired, we are focusing on this page as the first area for improvement and tweaks.

Our effort so far has been a focus group outreach to a credit class, a noncredit class, and two high school classes. We are compiling students' anecdotal feedback, and also examining homepage web analytics data to understand how the current page is being used. Additionally, we want to use our findings on "attitudinal brand research" to reinforce the MC keywords "affordable," "flexible" and "supportive" on the homepage.

So far, we are hearing that people like many things about the homepage, but because it was launched BEFORE the dropdown menu was available, with the dropdown's extensive listing of resource sections, there are repetitive links and visual components, that we want to revise in generally shortening the vertical length of the homepage. We're looking for a refresh that finds the sweet spot between the page being useful and aesthetically pleasing.
