Call to Order

There is a quorum to conduct business. The meeting was chaired by the Vice-Chair Shakenna Adams-Gormley in the College Councils Chair's absence. The meeting was called to order at 1:00 pm. The meeting was recorded for internal use only.

Approval of Agenda and Minutes

The agenda was approved with one change Dr. Dukes spoke before the Chair's Report. The agenda was approved as revised. The minutes for October 12, 2021 meeting were approved as written.

Return to Campus Follow Up (Dr. Charlene Dukes, Interim President)

Dr. Dukes follow up discussion to the Colleges return to campus on November 8, 2021

- 1. Montgomery College has been working remotely/home for 18 months.
- 2. To meet the needs of our students the Library services and Tutoring have been working face-to-face along with other offices throughout the College during the pandemic.

- 3. College now needs to focus on the return to face-to-face services to fulfill our mission on serving our Students and the Community.
- 4. Initially the College was scheduled to return to our physical locations on October 4, 2021.

 Because the College has put in place a vaccine or exemption requirement, the date has been changed to Monday, November 8, 2021.
- 5. The data from the county shows the numbers of COVID-19 cases are down to 50 transmissions per 100,000 individuals. This supports the intuitional agreement that the college has to support the return to our physical locations.
- 6. As an organization, the College has a systematic assessment of remote work and how it has impacted our College community, the student enrollment is down considerably.
- 7. The institution needs to adjust and readjust and focus on how to regroup and reset, and reacclimate to campus to meet the needs of our Students as well as the College Community. The College will continue to assess remote work and telework. Teleworking is available 1 day per week starting November 8th. Four weeks after the start of the spring semester 2022 an employee can request up to 3 days of telework per week with your supervisor/division approval.
- 8. The spring semester 70% of our classes will be taught face-to-face and 15% remote and 15% distance learning.
- 9. Reminder to all employees to have their vaccination cards uploaded by Friday, November 5, 2021 by 5:00 pm. There have been 1500 vaccination cards uploaded to date.
