Call to Order

The meeting was called to order by Chair Shakenna Adams-Gormley at 1:00 p.m., with a quorum present. The meeting was recorded for internal purposes.

Approval of Agenda and Minutes

Ramon De La Cruz moved to approve the minutes for March 25, 2025 and Nghi Nguyen second the motion. The meeting minutes for March 25, 2025, were approved as written. The agenda for the April 8, 2025, meeting was approved without changes.

Constituent Concerns

Dr. Roberto Gomez Jr., Chair of the Visual and Performing Arts Department at the Takoma Park/Silver Spring campus, raised concerns regarding the removal of a Pride flag from the Cafritz building by Facilities staff without prior communication. Despite the flag being part of a broader, multilingual display promoting inclusivity and belonging, it was taken down, returned

in a trash bag, and later questioned again when rehung inside the department suite. Dr. Gomez is seeking clarification on the application of posting guidelines and how to ensure expressions of support for diverse communities are respected and aligned with college policies moving forward.

Chair Adams-Gormley confirmed the concern was noted and would be assigned to a council member for follow-up with Facilities leadership.

Chair's Report

Dr. Debbie Van Camp provided updates on several policies, including the recently approved Bank Services policy and upcoming board reviews for Placement Assessment, Asset Management, and Acceptable Use of IT, with currently posted policies covering Institutional Risk Management, Anti-Hazing, and policy formulation processes. Council Updates

Council Chairs

Council chairs shared updates on goals and progress:

- **College Council:** Recommendation 25-01 was accepted; governance reports due May 23.
- **Operational Services:** Delivered ~600 items to Spiffy Closet.
- **Germantown Campus:** Promoting the baseball game; organizing Council seating and T-shirt giveaway.
- **Student Services & Success:** Investigating Spiffy Closet concerns; attended SGA meeting; next meeting includes IT updates.
- **Faculty Council:** Focusing on communication with IT/facilities; working on P&P awards.
- **WDCE:** Donated 145+ items to Spiffy Closet; 15+ mobile markets supported; hosting Racial Healing Circle.
- **Staff Council:** Continuing donations through May 1; 400+ attendees at Staff Enrichment Day.
- **Rockville Campus:** Focus on visibility; created flyers and hosted IT Help Desk presentation.
- **Administrator Council:** Focus on anti-racism badging and DEI training; monthly "Let's Talk Data" segment added.

- **Student Council:** Improved student participation and SGA collaboration; in-person meeting had strong turnout.
- **Academic Services:** Guest speakers each meeting; strong engagement; working on streamlining student support services.

PIC-MC Presentation

Executive Director PIC-MC, Tommy Luginbill

Tommy Luginbill shared that PIC MC originated as a technology park through a public-private partnership between Montgomery College, Montgomery County, and Holy Cross Hospital. The park now includes the Hughes manufacturing facility, a hospital, and a life sciences incubator, with students actively interning at the new 5G incubator. He emphasized the growing opportunities for experiential learning and community partnerships and encouraged future tours and collaborations with faculty and students. President's Remarks

President, Dr. Jermaine F. Williams

Dr. Jermaine Williams expressed gratitude to governance members and highlighted key celebrations, including Community College Month and the "Best Decision Ever" campaign. He recognized student achievements such as Montgomery College's first Goldwater Scholar and ten Jack Kent Cooke semifinalists, praised the East County Education Center for serving over 1,500 students in its first year, and commended the Communications team for earning national awards. Dr. Williams also acknowledged the staff's efforts in hosting impactful events like MC Experience and World of Work, reaffirmed the College's steadfast commitment to equity and inclusion, and announced the launch of two new websites to share college positions and support displaced federal workers.

Blackboard Ultra Update

Instructional Designer, Anna Donohoe

Anna Donohoe provided an update on the upcoming transition to Blackboard Ultra, which will be fully implemented for all courses beginning in Fall 2025. Faculty will retain access to their original Blackboard courses, and a range of support options are available, including self-paced modules, live virtual sessions, and in-person consultations. She encouraged departments to schedule custom training sessions before the semester ends and highlighted the availability of open labs and 24/7 support through the Blackboard Help Desk and ELITE team.
