Call to Order

• The regular meeting was called to order at 2:04 p.m., by Chair Christine Tracey.

Constituent Concerns

- Member David Neumann brought up a concern about employees and students still having to pay parking fees while we are working remotely.
- Member Andre Ferguson brought up a concern relates to the transparency and the legitimacy
 of information provided by the financial aid department. This is happening to many students
 and mostly pertains to the students that are prompt and timely in their financial aid submittal,
 though it can and should extend to all students.
 - o Information given to students is not consistent: I have been fortunate to have finally found some diamonds in the financial aid department. This was through the aide of certain counselors and professors acting on my behalf, as well as my own persistence. Financial aid staff can be a bit slow on the turn around time the department has as a default time for replies (I state this only for the students who do things in a timely manner). I have been told, (in a not so pleasant manor) to pay up even though I had enough financial aid to cover (person 1). I was then told by another (person 2) that I was okay and negated the comments of the initial person I spoke to. Fast-forward to another semester, the same individual (person 2) who refuted the colleague (person 1) initial claims all of a sudden restated information in support of that colleague. I have been in conversation with financial aid personnel who have put the responsibility of my financial situation unnecessarily on academic faculty who were trying to help me. The point is that all financial aid workers should be consistent and of one accord in divulging information to each student. It should be consistent. There should not be cracks in understanding when it comes to the students. Especially on one to one session explanations should be precise to that students' situation and reveal all applicable facts. I have noticed that there is a lot of maybe speech where it need not be.
 - Financial aid recipients are being caused undue financial stress: As a community college MC offers and affords students with the opportunity tho achieve goals and realize dreams. The success of a well-intentioned student can be hindered or cut off due to the "financial trappings" be it personal or educational. In my own journey in fear of refutation from necessary classes I have paid a sum of money before the semester

though my financial aid covered everything. I did this due to messages received from financial aid. As one of the millions of people who live paycheck to paycheck, this requires the forfeiture of things I may need for school to succeed or even basic needs. This causes stress and wastes energies which could be put towards academics.

- Some suggestions: Mobile Market, Advising Day (help rally students to go talk to counselor, adviser, etc.), Provide Venue to Networking (Professors/Students), RV Campus Council Newsletter.
- Actively promoting and breaking stigma around mental health, regularly get updates on mental health initiatives from SHAW and Rockville Counseling and Advising. With Counseling and Advising in Mannakee, it is often forgotten.
- Note that it is not just SHAW having mental health resources, Rockville Counseling and Advising does crisis intervention, short brief solution focused counseling with students, and Title IX. We are the only confidential informants for Title IX. We could promote/encourage Professors to request Title IX's Bringing in the Bystander program. I regularly present this. The number of Professors requesting it for their classes has gone down drastically, despite being a great program.
- Student Athletes. Rockville is the home of 8 of the 9 sports teams (baseball is at Germantown), They serve our campus by creating raptor spirit, opportunities for students, faculty, and staff to be entertained with their games and student engagement. The new soccer field will be the

first-time soccer has been on campus. Our student-athletes are going through a very difficult time and need support. There has been losses of identity, isolation, and much more. I don't think the campus understands what it means to have Division 1 and 2 sports. These students see their athletic talent as their ticket to access higher education. It is a very big deal and unique cohort with its own unique pressures.
