# Guest Speaker: Montgomery College New President -Dr. Williams

- Dr. Williams introduced himself indicated "3.5 weeks of Montgomery College employment. Possible work goals of 30 years, like other Staff Council Members"
- Dr. Williams reviewed some of the events of his busy weeks
  - o Attended Board of Trustees Meeting on Monday, March 21, 2022
  - o Attended College Council on Tuesday, March 22, 2022
  - Participated in the Leggett Building event last week with County Council Members and County Executives. Excited about the supportive community of staff, faculty, and students.
- Discussed Budget Request has been approved by the County and goes to vote.
  - o Increase in compensation/investment of MC employees
  - Freezes tuition for the MC students
  - Helps with goal of East County Campus
- Gave shout out to the Staff employees, being the backbone of the college during the pandemic.
- Mentioned excitement about the Student Successes:
  - o 10 students nominated for Jack Kent Cooke Scholarships
  - 2 International Scholars
  - Men and Women's Basketball Team and their playoffs
  - o MC Got Talent event today Dr. Williams and his 2 sons will be attending.
- Indicated gratitude to the staff.
- Dedication to Social Justice with compassion and empathy.
- Learning and positivity of MC's impact to society and the community
- Thanked Governance members for serving.
- Dr. Williams had two promises:
  - o 1. Rely on governance to keep him inform and he hopes to address in a timely

manner.

- 2. Will engage with the College Council to consult on specific issues like protocols and how to adjust our policies.
- Opened for questions/answer session.
  - Beth Reilly asked for a constituent: What is the future of Vaccine Mandate Dr.
    Williams indicated this still to be determined by transmission rates, college review, and future discussion.
  - Matthew Wilson asked about the 4<sup>th</sup> Campus/East Campus Dr. Williams indicated they are first looking for a location for the "East Education Center" for spring 2023 with the 7-10 year goal of an East Campus. The Campus may not be where the "center" is located.
  - Ramon De La Cruz stated about Montgomery College becoming a "Meta" College requesting information about needs and desires of 'virtual space', not limited to inperson opportunities.

  - o Dr. Shinta Hernandez presented about the MC Virtual Campus
  - Budget was moved forward by Montgomery County Council with compassion increase and tuition freeze, still needs to be officially approved.
  - Mask Optional was announced
  - Governance business has 6 weeks left in the fiscal year (3 meeting left for Staff Council).

# **Unfinished Business**

- Holiday Pay/Administrative Leave in Workday Constituent Concern Ramon De La Cruz reviewed that change to be listed as Operational Status – Change Time in workday.
- Employee Services Council follow-up Carla Ammerman reporting.
  - Leslie Jones from Human Resources presented information about New Staff Orientation and Best Practices in other organizations
  - Elaine Doong reviewed what is covered in the training bring presenters to discuss Ethics/Compliance, Equity and Inclusion, Benefits, etc.
  - o Review future thoughts about a "Buddy"/Mentor program
  - Will be performing an analysis of onboarding and changing back to in-person format with one long day on Mondays and 2<sup>nd</sup> half day on Thursdays
- Goal #1: "Improving the onboarding process of new employees through collaboration with other governance councils and establishing a mentorship network."
  - Christopher Standings recommended a list of mentors or nominations through a department for staff "honor" of mentoring a new employee. Also, mentioned to consider thoughts on who will "own" the program, how to promote the program.

  - Leslie Casey motioned to change goal #1 from "Improving the onboarding process of new employees through collaboration with other governance councils and establishing a mentorship network" to "Improving the onboarding process of new employees through collaboration with other governance councils and recommend a mentorship network." Lisa Dobbins seconded the motion. Voted and unanimously approved. Ramon De La Cruz will update and submit the change for approval.

college is in the orange or yellow area operations response, those employees do not 'work at home' on those days.
