How do I apply for Financial Aid at M C

STEP 1:

Complete a FAFSA

Submit your Free Application for Federal Student Aid (FAFSA).

STEP 2:

Submit required documents.

Check MyMC to access, complete and submit additional documents needed to complete your financial aid file.

STEP 3:

Check MyMC and your college email account often. Most Office of Student Financial Aid correspondence will be sent to you through your official Montgomery College email address. You should check your email at least once a week.

Montgomery College Financial Aid Summer 2022

Does Montgomery College offer student financial aid in the summer?

Yes, to receive summer financial aid, students must be in a degree seeking program at Montgomery College and register ONLY for classes that lead to a degree in their declared program of study (major) or approved certificate programs at MC. *We cannot provide financial aid to "visiting" students who are pursuing degrees at other colleges or universities.*

Which Free Application for Federal Student Aid (FAFSA) do I complete for summer?

ALL students must complete the 2021-22 FAFSA by June 30, 2022 to receive financial aid for summer 2022. If you have already completed this form and received financial aid for the fall 2021 and/or spring 2022 semesters, you do not need to complete it again. Students transferring to MC from other schools should go to <u>www.studentaid.gov</u> and add MC's school code – 006911 – to their FAFSA so the College can receive your information. If you did not attend MC in the fall or spring, but have registered for fall 2022 you must complete both the 2021-22 and 2022-23 FAFSAs. I received a Pell Grant in the fall and spring semesters this academic year. Can I receive the grant for summer?

Yes, students who received full-time Pell grants in fall 2021 and spring 2022 <u>may</u> have up to an additional semester of a scheduled award in one year. You **MUST** be enrolled in a minimum of 6 credit hours (combined Summer I and Summer II enrollment).

If you did not enroll full time in both semesters during the academic year, you may have remaining Pell grant available for summer from your initial yearly award. The financial aid office will calculate your summer Pell grant according to the level of your summer enrollment on a case by-case basis. We combine your enrollment in Summer I and Summer II to determine your total summer enrollment.

IF your expected family contribution (EFC) is greater than 3900 you must be enrolled for a minimum of 6 or more credit hours to receive Pell Grant. If your EFC is between 5101 and 5846, check with the Office of Student Financial Aid regarding your specific EFC and credit hour requirements to receive summer financial aid.

May I borrow a Federal Direct Stafford Loan for summer?

You must have completed a minimum of six credit hours in the spring 2022 semester and enroll in at least six credit hours in summer 2022 (combined Summer I and Summer II enrollment) to qualify for a Federal Direct Stafford Loan. If you borrowed your maximum annual loan eligibility during the fall 2021 and/or spring 2022 semesters, you may not have remaining Direct Loan eligibility for summer 2022. Contact the Office of Student Financial Aid to check your remaining loan eligibility. *Submit the Loan Change Form, located in the MyMC portal. "Click" on Financial Aid and scroll down to the General Financial Forms box and select* 2021-22 Direct Stafford Loan Change Form.

Does MC offer any other grant assistance for summer?

Other grant assistance is usually not available for summer. Only grants not fully awarded in fall and spring, do we have remaining institutional aid for summer. If funds are available, they are awarded for summer session I to students who already have an application on file.

Is there any financial aid for recent high school graduates?

Yes, if you graduate from high school in May or June 2022. To determine Pell Grant eligibility, you must complete the 2021-22 FAFSA by June 30, 2022. You must also complete the 2022-23 FAFSA to continue receiving aid for the 2022-23 school year.

Not eligible for summer Aid?

If you are not eligible for financial aid for any reason, you will be responsible for 100% of all tuition and fee charges.
